

## To our current and potential Food Concessions Vendors

I invite you to join us for the Eufaula Whole Hawg Days® Arts & Crafts Show, the flagship event of the Eufaula Whole Hawg Days® Festival which will be held this year on July 28-29, 2017. If my math is correct, then this will be the 19<sup>th</sup> consecutive year that my wife Kathy and I will be serving as your hosts for the Arts & Crafts Show. Many of you are often surprised that when you call or write to us that we live in Indiana. Well, there's a long story about that, but suffice it to say that even though we are "Hoosiers" now, we were "Okies" for many, many years and spent our best years in Eufaula. We enjoy returning every year, seeing many old friends and familiar faces, and planning a little "working vacation" in Oklahoma around this great event.

We like to have Food Concessions Vendors that we know and trust, plus ones that our customers like and recognize. Because of that and the fact that we have a "loyalty policy" with our current Food Concessions Vendors, they will be mailed their applications EARLY. If they would like to return to our show again this year, then they have until **MONDAY, MAY 22, 2017** to respond. After that early time window has expired, then I will be contacting other Food Concessions Vendors who have expressed an interest in being in our show.

It is also important that you realize we only have SIX Food Concessions Vendors in the Park. This is due to our recent electrical upgrade (that we invested in considerably). **Generators are not allowed unless only in the most special of circumstances and only then if they are "super quiet."** We have 50-amp outlets available, one per Food Concessions Vendor, and also an additional FOUR 30-amp outlets for an additional charge on a first come, first served basis. Also, please make sure that you have enough cord to reach the outlets. **(150' is suggested)** ***If you need to see a diagram of the plugs that we have, I can send you one.*** We also have enough water pressure in the Park to adequately serve all of our Food Concessions Vendors so that they can hook up directly to our water service. You will not have to haul water by bucket or pail to your tanks! You will, however, need to make sure you have a "Y" or "T" adaptor so that everyone can get hooked up and also have plenty of hose to reach it. **(150' is suggested)**

In addition, I also call your attention to a point that I mention in the general information letter for all Vendors. With the adjacent carnival running well into the night on both Friday and Saturday, you might want to consider being open at that time as well. We normally have a pretty decent crowd on Friday night after the parade, and it usually lasts for several hours thereafter. The same thing happens on Saturday nights, too. It's just something to keep in mind; it's totally up to you if you want to stay open later or not.

I would also like to mention "exclusivity" of products sold. There is always going to be some crossover of products offered by more than one of you and that is inevitable and unavoidable. As such, there is a general **NO EXCLUSIVITY OF PRODUCTS POLICY**. However, when only one product makes up a **SIGNIFICANT MAJORITY** of your sales, then I will deem that product "untouchable" by other vendors (for example: home made root beer or similar product, kettle corn, turkey leg, etc.) If you have questions about a specific item, then you need to run that by me **BEFORE THE SHOW** – and my decision will be final! Please also remember that you must have all permits and liability insurance as required by law. I also remind you that you will have your facilities inspected by the local health inspector before you will be allowed to open for business.

NOTE THAT PRICES ARE FOR A 30' wide x 15' deep space (30' facing the front). If you have a trailer that is longer than 30' (including tongue), then your trailer is TOO BIG for our show! If you serve out of the "front end" of your trailer and need to turn the trailer "long ways" in the space, we may not be able to handle depths much beyond 20' – ask first before you reserve your space to make sure it's okay.
